The Cooperative Republic of Guyana has received financing from the World Bank toward the cost of the Guyana Secondary Education Improvement Project, and intends to apply part of the proceeds toward payments under the contracts<sup>1</sup> for **Supply and Delivery of New Computing Devices and ICT Equipment for Teachers and Students (Lots 1-3)**.
2. The Ministry of Education now invites sealed Bids from eligible Bidders for the **Supply and Delivery of Computing Devices and assorted Equipment for classrooms** in 25 secondary schools across the 10 administrative regions of Guyana. The delivery period is expected to be 3 months from contract signature. The Margin of Preference is not applicable.
3. Bidders may Bid for one or several contracts, as further defined in the request for bids document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid.
4. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" [July 2016] edition as per legal agreement] ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
