1. **Guyana Livestock and Development Authority (GLDA)** hereinafter referred to as “the Procuring Entity”, invites eligible bidders to submit their bids for execution of the works
 - **Lot 1-3 Construction of Sheep Pen at GLDA Farm, Mon Repos, Region No.4**
 - **Lot 4- Construction of Sheep Pen at Farm, Ebini, Region No.9**
 - **Construction of Bull Exercise Facility at GLDA Farm, Mon Repos, Region No.4**
2. Bidding will be conducted through the National Competitive Bidding (NCB) procedures, specified in the Procurement Act 2003 and is open to all bidders.
3. Interested bidders may obtain further information, familiarize and purchase a complete set of Bidding Documents (in PDF on a Flash Drive) upon having a written request and after the payment of a **non-refundable fee in the amount of Five Thousand Guyana Dollars (5,000 GYD)**. The Commencement date for the inspection/acquisition of Bidding Documents is **March 16th, 2023** between 8:30 hours to 16:00 hours on Mondays to Thursdays and Fridays from 8:30 hours to 15:00 hours at the **Guyana Livestock Development Authority, Agriculture Road, Mon Repos E.C.D, Telephone No. 220-6556**.

The Bidder will be required to:

- Submit one (1) Hardcopy and an electronic copy (flash drive only) with an exact PDF version of the hard copy tender (Applicable).
 - Ensure the envelopes of the hardcopy and electronic copy are identically labelled (Applicable).
 - The Electronic copy (flash drive) should be placed in a smaller envelope and properly affixed to the hard copy submission (Applicable).
4. All bidders should submit their bids not later than **9:00** hours on “**4**” day of **April, 2023** at the address below:

 5. Bids should be valid during 60 days of the date of bid opening.
 6. All late bids shall be rejected and returned. Bids shall be opened by tender commission in the presence of the bidders’ representatives who wish to attend it at **9:00 hours on “4th day of April 2023** at the address: **The Chairman, National Procurement and Tender Administration Board Ministry of Finance, Main & Urquhart Streets, Georgetown**. or may request a video link from npta.procurement@finance.gov.gy.
 7. The National Procurement and Tender Administration, Ministry of Finance reserves the right to reject any or all bids without assigning any reason whatsoever and not necessarily to award to the lowest bid.

All Local and International bidder of all types interested in government contracts are being urged by the National Procurement and Tender Administration (NPTA) to register their business in accordance with section 4A (2) of the Amended Procurement Act dated 12 June 2019 “.....Every supplier or contractor shall apply to be registered as a bidder in the register of bidders in order to participate in procurement proceedings at least seven (7) days before taking part in any procurement proceedings.....”
