**Construction and Installation of Abattoir and Other Related Infrastructures in Region # 5
(RETENDER)**

1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business, on June 8, 2017. The Cooperative Republic of Guyana has received financing from the Inter-American Development Bank toward the cost of the Sustainable Agricultural Development Project (SADP), and it intends to apply part of the proceeds of this loan to payments under the Contract for the above-mentioned project.
2. The Ministry of Agriculture now invites sealed bids from eligible and qualified bidders for the Construction and Installation of Abattoir and Other Related Infrastructures in Region # 5. The period for construction and installation of the abattoir is 12 calendar months.
3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Inter-American Development Bank's *Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank* (GN-2349-9) and is open to all bidders from Eligible Source Countries as defined in the Bidding Documents.
4. A complete set of bidding documents on CD (in PDF) in English may be obtained at a non-refundable cost of G\$1,000 by interested bidders on the submission of a written application to the address given below. The Commencement date for the inspection/acquisition of bidding documents is **19th August 2022**. Upon request, local and international prospective bidders will be sent a copy of the bidding documents free of cost via email.

5. Qualifications requirements include:
 - a) **Financial Capability**
The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):
 - I. Minimum average annual turnover of G\$200,000,000 as total payments received for contracts in progress or completed, within each of the last five (5) years,

- II. The bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet cash on hand of **G\$100,000,000**
6. All bids must be accompanied by a Bid Security of Eight Million Guyana Dollars (G\$8,000,000) or Thirty-Eight Thousand, Five Hundred United States Dollars (US\$38,500) or equivalent amount in a freely convertible currency and to be submitted with the original bid. A Bid Bond from an insurance company or Guarantee from a Bank is accepted.
 7. The site visit and pre-proposal conference will commence on September 1, 2022, commencing at MMA/ADA Entrance then proceed to the site, at 11:00 hrs. The cost of the visit for the contractor's personnel shall be the responsibility of the contractor.
 8. Bids must be valid for 180 days of the date of bid opening.
 9. All bidders must place their bids together with the bid securities before **9:00 hours on September 22, 2022, at 9:00 am** in the tender box of the National Procurement and Tender Administration Board and addressed it to the Chairman, NPTAB, Ministry of Finance, Main and Urquhart Streets, Georgetown. The submission of all bids must be per the instructions given in the Instructions to Bidders (ITB) of the Bidding Documents. Bids shall be marked "Construction and Installation of Abattoir and Other Related Infrastructures in Region # 5" on the inner and outer envelopes.
