Bidders are to ensure the envelopes of the hardcopy and the electronic copy are identically labelled; Electronic copy (flash drive) should be placed in a smaller envelope and properly affixed to the hardcopy submission, addressed to the Chairman, National Procurement and Tender Administration Board, Ministry of Finance, Main and Urquhart Streets, Kingston with the name of the project clearly marked on the top left hand corner “Procurement of Enterprise Wireless Network Solution Equipment – Ministry of Finance”. The envelope in no way should identify the tenderer.**
