3. Interested eligible bidders may inspect the Bidding Documents and obtain further information from the Procurement Office, National Drainage and Irrigation Authority during normal working hours.

Bid documents will be available from **January 20th, 2022** and can be uplifted from the office of the National Drainage and Irrigation Authority, cashier's cage Finance Building, Ministry of Agriculture, Regent Street and Vlissengen Road, Georgetown upon payment of a non-refundable fee of Three Thousand Dollars (\$3,000) in favour of National Drainage and Irrigation Authority for each bid document
5. Bids shall be submitted in a plain sealed envelope bearing no identification of the Bidder and marked on the top left hand corner “Tender for _____”.

6. Bids will be opened in the presence of those bidders or their representatives who choose to attend at **09:00 hours on Tuesday February 15, 2022** in the boardroom of the National Procurement and Tender Administration Board, Ministry of Finance at the above address.
7. All bids must be accompanied by valid certificates of compliance from the Manager of the National Insurance Scheme and the Commissioner of the Guyana Revenue Authority.
8. All bids must be accompanied by a bid security amounting to the value specified in the bid document.
9. The National Procurement and Tender Administration, Ministry of Finance reserves the right to reject any or all bids without assigning any reason whatsoever and not necessarily to award to the lowest bid.
